Strengthening Monitoring & Evaluation Systems with Governments

D4I implements activities in partnership with local institutions, including governments at the national and subnational levels, to generate evidence, ensure data quality, integrate gender, and promote data use. D4I collaborates with local governments to strengthen monitoring and evaluation (M&E) through mutuality, the development of tools, and fostering local ownership of processes and priorities. Additionally, D4I supports governments with tailored technical assistance in knowledge translation and data use to strengthen M&E systems to generate timely, actionable evidence for informed decision making.

USAID's Support of the Bangladesh Ministry of Health & Family Welfare's Program Management & Monitoring Unit

Since 2012, USAID Bangladesh has supported the Bangladesh Ministry of Health and Family Welfare (MOHFW), Program Management and Monitoring Unit (PMMU) through the Technical Assistance Support Team (TAST) to oversee the country's sector-wide health programs. This support focused on strengthening the capacity of the PMMU to efficiently use high quality routine health information and evaluations for evidence-informed decision making. Over time, key areas of TAST support have included the development of key M&E frameworks, coordination of data collection, and facilitation of program reviews. Strengthening Capacity for Child Protection Policies and Case Management

In 2019, the US Government launched the [Advancing Protection and Care for Children in Adversity Strategy for International Assistance](#). D4I works with USAID's Children in Adversity team to foster positive impacts for children made vulnerable by conflict, violence, and neglect. [D4I has supported governments in Armenia, Cambodia, Colombia, Moldova, Rwanda, Uganda, and Zambia](#) in policy reform, case management for children, and M&E of programs.



Envisioning the Future of the Social Service Workforce Planning

How can countries use demographic data to make a case for investing in the social service workforce (SSW)? Through an assessment, D4I has identified promising approaches to strengthen the SSW and broader systems related to child care and protection in Armenia, Cambodia, and Rwanda. Case Management Information Systems for Child Protection and Care

Government child protection agencies can use case management information systems (CMIS) to ensure that caseworkers have the tools and resources needed to meet families' needs effectively and efficiently. Promoting Health Equity in Armenia through Counter-Trafficking in Persons Activity

D4I partnered with the Armenia Ministry of Labour and Social Affairs in leadership and



coordination to strengthen the country's counter-trafficking in persons (C-TIP) response. D4I has supported the government in addressing drivers of trafficking by establishing monitoring and oversight systems. Developing Indicators with Front-line Workers to Improve Child Protection and Care in Colombia

In Colombia, D4I supported the Colombian Institute of Family Welfare (ICBF) to strengthen the collection and use of high-quality routine data and to [develop and prioritize indicators](#) for M&E of child protection and case management.



Supporting the Government of Moldova in Data Use

In Moldova, [D4I mapped indicators](#) for monitoring the rights of persons with disabilities and developed Moldova's [first compendium on disability](#).

D4I has supported the government in Moldova to launch two Data Review Rooms in [Ștefan Vodă rayon](#) and [Chișinău](#) to facilitate regular, timely, and targeted review of data available on Ukrainian refugee children and families transiting or living in Moldova.



Building Digital Skills in the Child Protection Workforce

D4I explored how to assess the digital competencies of child protection staff using the [Digital Skills Assessment Guide](#). The guide covers what digital competencies are needed, how to assess them, and how to use assessment results to improve digital skills. D4I hosted a [webinar](#) with child protection and digital specialists and [piloted the guide in Uganda](#).
